## In the Spotlight..... Eyes on the Baby

#### 'Eyes on the Baby' – Developing a Multi-Agency Approach to Preventing Sudden Unexpected Death in Infancy (SUDI)

Rates of SUDI have fallen sharply in the UK over the last 30 years, largely due to widescale infant sleep messaging over recent years, such as the <u>Lullaby Trust's 'Back to</u> <u>Sleep' campaign</u>. As a result, most sudden and unexpected deaths of babies in England now cluster in the most deprived communities – where simple public health messages can be difficult to implement. Most unexpected deaths of babies under 1 year occur in families living in impoverished circumstances with multiple risks or vulnerabilities, and a multi-agency approach is needed to reach the families most at risk of infant death. In

2020 a report from the National Child Safeguarding Practice review panel recommended that tackling SUDI in the UK is too challenging and complex to expect that any further reductions in infant deaths in the UK can be accomplished by health professionals alone.

Eyes on the Baby' is a collaboration between Durham University's Infancy and Sleep Centre, Durham Integrated Care Board, Durham County Council Public Health Team and partners. This project supports the implementation of a multi-agency approach to tackling Sudden Unexpected Death in Infancy (SUDI). The work identified a wide range of staff groups in County Durham whose work brought them into contact with vulnerable families with babies and developed a training programme for those groups of staff, to enable them deliver situationally appropriate 'safe sleep' support or advice. The training programme was offered to those groups of staff across County Durham, and its impact was evaluated. The 'Eyes on the Baby' multi agency training has been designed to help staff prevent SUDI (Sudden Unexpected Death in Infancy) in Darlington and will help practitioners give advice about safer sleep, support shared working between services, and keep Eyes on the Baby to reduce SUDI. Eyes on the Baby training is now available in Darlington on Me Learning as part of our training offer <u>here</u>.

#### PHILIP AND LORAINE LEARNING LESSONS REVIEW

Darlington Safeguarding Partnership has published a Discretionary Learning Lessons Review for Philip and Loraine.

Philip and Loraine were father and daughter who lived together in a privately owned home. In May 2023, a fire occurred at the property and sadly, both Philip and Loraine died. A joint fire and police investigation found evidence of hoarding and self-neglect. The review looked at how services worked together to support Philip and Loraine over a four year period prior to their deaths and identified a number of key learning points. The following themes were identified.

- Understanding the root cause of self-neglect and hoarding
- Understanding Hoarding Disorder •
- Working with individuals who are resistant to access appointments or • interventions
- Smoking and Fire Risk
- Mental Capacity Act and Code of Practice Awareness
- Carrying out mental capacity assessments •
- Information Sharing solutions to enable agencies to be aware of actions taken for high risk or complex cases
- Practice issues relating to multi-agency meetings

Organisations are encouraged to review the LLR Report and consider and apply the learning to their own practice. The Partnership are finalising how it will be sharing the learning from the review which will include the development of an executive summary and short briefing documents based on the themes identified.
