PUBLICATION OF REVISED MULTI-AGENCY SAFEGUARDING ADULT PROCEDURES

Darlington Safeguarding Partnership has revised its Safeguarding Adult Procedures which involved consulting and working closely with multi-agency partner organisations.

Safeguarding is everyone's responsibility and for services to be effective each individual and organisation should play a part. The procedures aim to protect adults with care and support needs from abuse and neglect and are applicable to all those working in the Darlington locality who have responsibility for adults with care and support needs.

Effective safeguarding practice can only be achieved when organisations work together and ensure that adults with care and support needs are protected, and that the outcome of the safeguarding process is life enhancing. This policy is intended for all agencies and individuals involved in safeguarding adults including managers, professionals, volunteers and staff working in public, voluntary and private sector organisations. They are also relevant to those who commission services to adults with care and support needs.

Darlington Borough Council is the lead agency for adult safeguarding, however all agencies within Darlington Borough Council boundary have safeguarding responsibilities. These procedures reflect the Care Act 2014 and should be used in conjunction with organisational guidelines.

The procedures represent the commitment of organisations to:

- work together to prevent and protect adults at risk from abuse
- empower and support people to make their own choices
- investigate actual or suspected abuse and neglect
- support adults and provide a service to adults at risk who are experiencing abuse, neglect and exploitation achieve the best possible outcome for the person at the centre of the enquiry

The procedures are now live on the DSP website and provide a lot of information and guidance to support practitioners within organisations.

Learning Session Information: These sessions are aimed at upskilling professionals in the topic area and identifying points of reflection for individuals' own practice and to take back to their wider teams and networks. The audience is expected to be varied and therefore the session has been written to engage professionals at different levels of knowledge and seniority and across a range of setting and sectors.

Online Safety

Ofcom has published a news story about the latest measures to address online harms and how it is enforcing the Online Safety Act. Providers of services in scope of the Act had until 16 March to carry out an illegal harms risk assessment. From 17 March, the next set of illegal harms duties has come into force; platforms must now start implementing appropriate measures to remove illegal material quickly when they become aware of it, and to reduce the risk of 'priority' criminal content from appearing in the first place. Ofcom will be assessing platforms' compliance with the new illegal harms obligations under the Act and launching targeted enforcement action where there are concerns. The news story also provides details of Ofcom's enforcement programme to tackle child sexual abuse imagery on file sharing services.

Online Child Sexual Extortion

The Guardian has published a news story reporting on the launch of the National Crime Agency's (NCA) awareness campaign tackling online child sexual extortion or 'sextortion'. Figures shared by the NCA found that within the first five months of 2024, police forces received an average of 117 reports of sexual extortion from under-18s each month. The article shares details of the awareness campaign and reports on an increase in digitally manipulated or AI -generated sextortion attempts.
